## Virtual Zoom Meeting - 7pm - April 3rd

DMC Community - we have to get creative in this season of "distancing." For that reason, we will be holding a VIRTUAL meeting, via Zoom, for our April meeting.

**Start by creating a **free** Zoom account:**

**Step 1:** Go to <https://zoom.us/>

**Step 2:** Click the blue "Sign up/it's free" button in the top right and follow instructions to create your free account.

**Step 3:** Install the Zoom App on your smartphone, tablet, computer.

For **smartphones/tablets:** Go to Apple Store/Google Play and install the "Zoom Cloud Meetings" app

**Step 4:** Once installed, sign in with the Zoom account you created above.

**QUESTION: What if I, or someone I know, doesn't have a smartphone/tablet/computer?**

Anyone can join a Zoom meet from a simple phone (cell or landline) by making a phone call. This will be sound only (no video), but works seamlessly.

When prompted, enter the 9-digit Meeting ID for the meeting listed above.

**QUESTION: What if my computer does not have a camera or microphone?**

You can connect both via computer and phone at the same time.

Connect your computer as above and you will "see" everyone gathered, as well as visuals during the service (they just won't see you.)

Call in as above, simultaneously, and you will hear all the audio, and others will be able to hear you.

# Extra Zoom Help!

## **Rule #1: Be patient with yourself and the process!**

We are an eclectic group of individuals with varying technical skills and backgrounds. Sandi and Mark will start a "helpline" at 6:30 p.m. on April 3rd for those who may need a little more help or time getting set up.

The most important thing is that you can hear and see what is happening. If for any reason we aren't able to hear you - it's ok! Use your phone to call in on the number above and then you can likely speak through your phone and watch on your computer.

The process usually works for about 90% of the people who get on a call. If you are in the other 10%, please be patient with yourself and us as we do our best to navigate these uncharted COVID-19 times.

## DMC Retro FunRun 2020 - Four Corners

**Saturday Aug. 8th to Monday Aug. 10th**

**OPTION: Extend your stay through Tuesday August 11th**

The DMC board and other club volunteers have had to make the hard choice in changing both the date and the destination for this year's FunRun due to calendar conflicts. However, moving this year's event from September to August and heading to the Four Corners area of the **USA** should prove to be a true highlight on this year's calendar!

## **SCHEDULE:**

**Saturday Morning** - Depart Phil Long Ford for arrival in the town of Cortez where we will stay in our hotel for the next two nights. Upon arrival, participants will be greeted by a welcome reception followed by Retro BBQ!

**Sunday Morning** - head out and visit both the **Four Corners Monument** as well as the beautiful **Mesa Verde National Park**. Once back from our Sunday route, we will have an awards dinner. Last year's was memorable and we are excited to put another one of these in the books!

**Monday Morning** - check out of the hotel in Cortez. You choose your ending!

1. Those who wish to head home may leave at their leisure.
2. For those who wish to extend the weekend, DMC is offering an option for an additional day of fun. We will go to Durango and take a trip on the scenic **Durango & Silverton Narrow Gauge Railroad** and then stay Monday night at a hotel in lovely Pagosa Springs. (This option is available for an additional charge. See below.)

**Tuesday** - for those who opt to stay the extra day, we'll check out in the morning and head home. This completes the 2020 FunRun!

**Space is limited to 33 rooms.** Space saved on a first-to-deposit basis. We promise to make things fun and provide for a few surprises along the way!

## **Pricing:**

- \$375 Single occupancy for the FunRun
- \$615 **estimated** per Single for the FunRun AND one day extension
- \$500 Double occupancy for the FunRun
- \$850 **estimated** double occupancy for the FunRun AND one day extension

These prices reflect food and lodging expenses for Saturday through Monday. Tuesday meals are on your own.
